



## *Ohio Dairy Goat Association* 2022 BUCKEYE CLASSIC SHOW RULES

1. THIS SHOW IS SANCTIONED BY THE AMERICAN DAIRY GOAT ASSOCIATION AND ADGA RULES SHALL GOVERN. The Ohio Dairy Goat Association (ODGA) Show Committee has the right to interpret any rules not adequately covered here or by ADGA.
2. The Combined Senior/Junior and Junior Doe shows are separately sanctioned by ADGA for the following breeds: Alpine, LaMancha, Nigerian Dwarf, Nubian, Saanen, Toggenburg, All Other Purebreds (AOP), and Recorded Grade.
3. The order of the show will be: **Rings 1 and 3:** Alpine, Lamancha, Nigerian Dwarf, Nubian, AOP, Saanen, Toggenburg, Recorded Grade. **Rings 2 and 4:** Nigerian Dwarf, Alpine, Lamancha, Saanen, Nubian, AOP, Recorded Grade, Toggenburg. The Show Committee reserves the right to change the show order as needed to keep the show running in an orderly fashion.
4. Does must be checked in and in place by 8:00 am each show day. Check in times are Friday 2:00 pm – 8:00 pm and Saturday 6:00 am – 8:00 am. Does showing only on Sunday need to be checked in and in place by 8:00 am Sunday. Animals are released when they have completed showing.
5. An original Registration/ Recordation Certificate is required for all animals six months of age or older. An original Registration/ Recordation Certificate or a valid Duplicate Application stamped by ADGA is required for animals less than 6 months of age. No copies, telephone calls or other electronic means will be accepted in lieu of original Certificates. All Registration/ Recordation Certificates must be presented for check in. Base date is the date of the show. Current guidelines from ADGA regarding registration certificates and stamped duplicates will be followed.
6. A current Certificate of Veterinary Inspection within 30 days of the show is required for ALL OUT OF STATE ANIMALS. Animals arriving will be inspected by a veterinarian or show committee member. Any animal exhibiting visible signs of infectious diseases will not be permitted to be unloaded or to show. The decision of the veterinarian will be final. GOATS ARE TO ARRIVE ONLY DURING THE TIMES NOTED AND ARE NOT TO BE UNLOADED UNTIL THE HEALTH CHECK HAS BEEN COMPLETED. EXHIBITORS WILL BE PROVIDED A CHECK-IN CARD AND IT SHOULD BE PRESENTED TO THE BARN STEWARD FOR PENNING AND AT THE REGISTRATION TABLE FOR CHECK-IN. Anyone requiring veterinary services will be responsible for any expenses incurred for their animals.
7. All animals must be from herds that are registered in the National Scrapie Database. They must be properly tattooed or tagged with proper identification. For more information on the National Scrapie Database program call the U.S. Department of Agriculture at (614) 469-5602.
8. No horned animals allowed. No dogs are allowed in the barns or show arena. Exceptions will be made only for working service dogs.
9. Animals arriving for a class after judging begins will not be permitted to compete in the class and entry fee is forfeited.
10. There is no pre-show milk-out. Milk your does with the show order in mind. Over-uddering is prohibited and judges reserve the right to dismiss any animal from the ring for over-uddering.
11. Champion Challenge Class: Proof of Championship can be either the prefix CH, GCH or SGCH as affixed by ADGA on the animal's Registration/ Recordation Certificate, or presentation of the Notification Letter issued by ADGA in conjunction with the original Registration/ Recordation Certificate. The letter is valid for

show purposes until December 31<sup>st</sup> of the year of issuance, after which the Certificate/ Recordation must be officially updated.

12. To be eligible to place in the Futurity, a doeling must be nominated as a kid and total fee paid with the nomination. Futurity does must be entered in their regular breed classes to be placed for Futurity awards.

13. Paid entry indicates acceptance of all show rules and regulations. The Show Committee reserves the right to interpret any show rule not adequately covered by these or ADGA rules. By entering, exhibitors agree that photographs of animals and exhibitors/ attendees may be published on ODGA's website and social media without written consent.

14. Any person not acting in an honorable manner, as judged by the show committee, **will be asked to leave the fairgrounds immediately and will not be permitted to return for the remainder of the show.** Parents/guardians or a responsible adult are required to supervise minor children **at all times.**

15. The Ohio Dairy Goat Association and the Morrow County Agricultural Society, it's members or associates, will not be responsible for the loss, damage, theft, injury or illness to animal(s), equipment, or persons attending.

16. **Payback will be as follows:** BIS-\$20.00, BOB-\$15.00, 1<sup>st</sup>-\$8.00, 2<sup>nd</sup>- \$4.00, 3<sup>rd</sup>- \$2.00. This will be for Combined SR/JR Doe Show and JR Doe Show. Payment will be done by PayPal show treasurer will need email associated with exhibitors PayPal account and that show treasurer is authorized to send money through PayPal.

#### **ENTRIES:**

\$8.00 per goat, per ring or \$30.00 per goat if all 4 rings are entered.

\*No charge for showmanship. Showman's age will be determined as of January 1, 2022. Youth should wear white in the show ring.

\*All fees must accompany entries and are non-refundable.
